AIM: The Organization


- >Who: Representatives from all 64 NCIRD awardees (50 states, 6 major cities, 8 territories/federated states)





AIM 2022 Annual Survey Results








Legislative Landscape


- 492 vaccine-related bills introduced in 2021 state legislative sessions; 594 in 2022
- Over 600 introduced so far in 2023
- At least 24 states passed laws limiting COVID vaccination requirements or verification
- Strong trend to limit state public health authority


CDC-Funded Pediatric COVID-19 Projects

2023 Vaccine Access Cooperative (VAC) **In-Person Regional Meetings**

- AIM is partnering with the National Academy for State Health Policy (NASHP) and AcademyHealth to hold 8 in-person regional meetings in the spring and summer of 2023 focused on pediatric vaccination
- These meetings will bring together leaders from state departments of health, immunization programs, and Medicaid programs, as well as the American Academy of Pediatrics, the American Academy of Family Physicians, pharmacy associations, and other key immunization partners

Barriers to COVID-19 Vaccinations

- Contracted with Mathematica to conduct interviews, focus groups, and electronic surveys of pediatric medical providers to understand barriers to providing COVID-19 vaccinations to children and the potential impact of commercialization
- Conducting similar scan of pharmacists to understand training, storage and handling, and oversight of vaccine administration



COVID-19 Lessons Learned & Focus Groups

- Designed to understand successes and challenges of COVID-19 vaccine campaign and of vaccinating children against COVID-19
- Facilitated discussion at AIM Conference, follow-up interviews, listening sessions, environmental scan of lessons learned



Learning Management & e-Learning

- Creating 6 e-learning modules for PMs and staff
 - Achieving Pediatric COVID-19 Vaccine Equity
 - **Ensuring Pediatric COVID-19 Vaccine Access**
 - Promoting Pediatric COVID-19 Vaccine Confidence
 - **Developing Pediatric COVID-19 Vaccine** Partnerships and Engagement

- Housed within a new learning management system to recommend and track learning




Promising Practices: COVID-19 Vaccination

- Contracted with Mathematica to identify and evaluate 5 promising practices to improve COVID-19 vaccination rates in children, including:
 - Policy
 - Cost/benefit
 - Feasibility analysis
 - Developing implementation guides



Media Library

- Resources to promote childhood vaccination
 - Including COVID-19
 - Co-branded and used by other immunization partners



VFC and Pharmacies Workgroup

- **Purpose**: works to identify and address challenges related to enrolling pharmacies in VFC; provides opportunity for awardees to share experiences, challenges, and successes related to enrolling pharmacies in VFC.
 - Chair: Dave McCormick (Immunization Program Manager, Indiana)


Environmental scan of jurisdictional challenges, successes, and views on enrolling pharmacies in VFC (summer 2022)

Upcoming in 2023

- White paper to be published in Spring 2023 addressing:
 - VFC program requirements
 - Burden to IZ programs
 - Legal limitations
 - Logistics on vaccinating young children
 - Incentives/disincentives for pharmacists
 - Equity and access

Pilot Community of Practice

- **Purpose**: Engaging immunization programs, along with their partners from AAP, AAFP, Medicaid, and others, in ongoing technical assistance calls to help improve COVID-19 vaccination rates for children
 - Immunization program manager builds a team of at least four key partners
 - Monthly technical assistance calls with AIM SMEs
 - Develop work plan
 - Connected to other jurisdictions that have had success in areas of interest
 - SMART objectives and measurable outcomes
 - Identify lessons learned and refine process to replicate with a greater number of jurisdictions

AIM assists the 38 REACH recipients plan/carry out local, culturally appropriate programs to address racial and ethnic disparities in immunization



Each recipient implements vaccine awareness, access, and confidence activities tailored to meet the needs of the populations they serve.



AIM Reminder Recall Program

- AIM assists awardees in notifying individuals that they or their child(ren) are due for vaccinations, through the Reminder/Recall postcard campaigns to prompt vaccine catch up.
- AIM is analyzing evaluation results from completed campaigns in California, Nevada, Michigan, Louisiana, and Wyoming
- In FY23 AIM will continue to support selected immunization programs in implementing Reminder/Recall projects.






