  - Majority of vaccine deserts are in rural areas (northwestern and northeastern Ohio)
- Opportunities
  - School-located vaccination
  - Recruit non-vaccinating providers in vaccine deserts, especially in northwestern Ohio

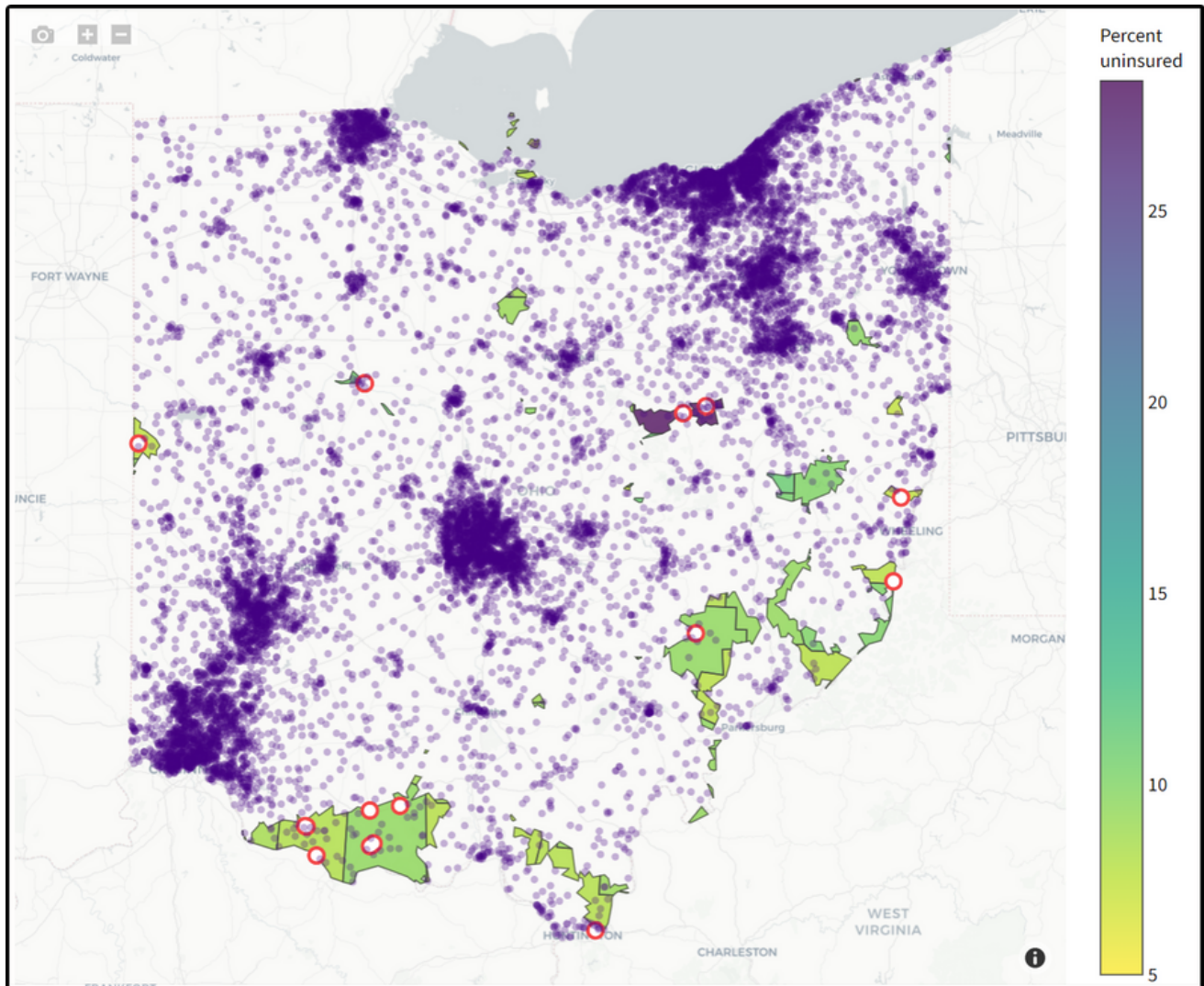

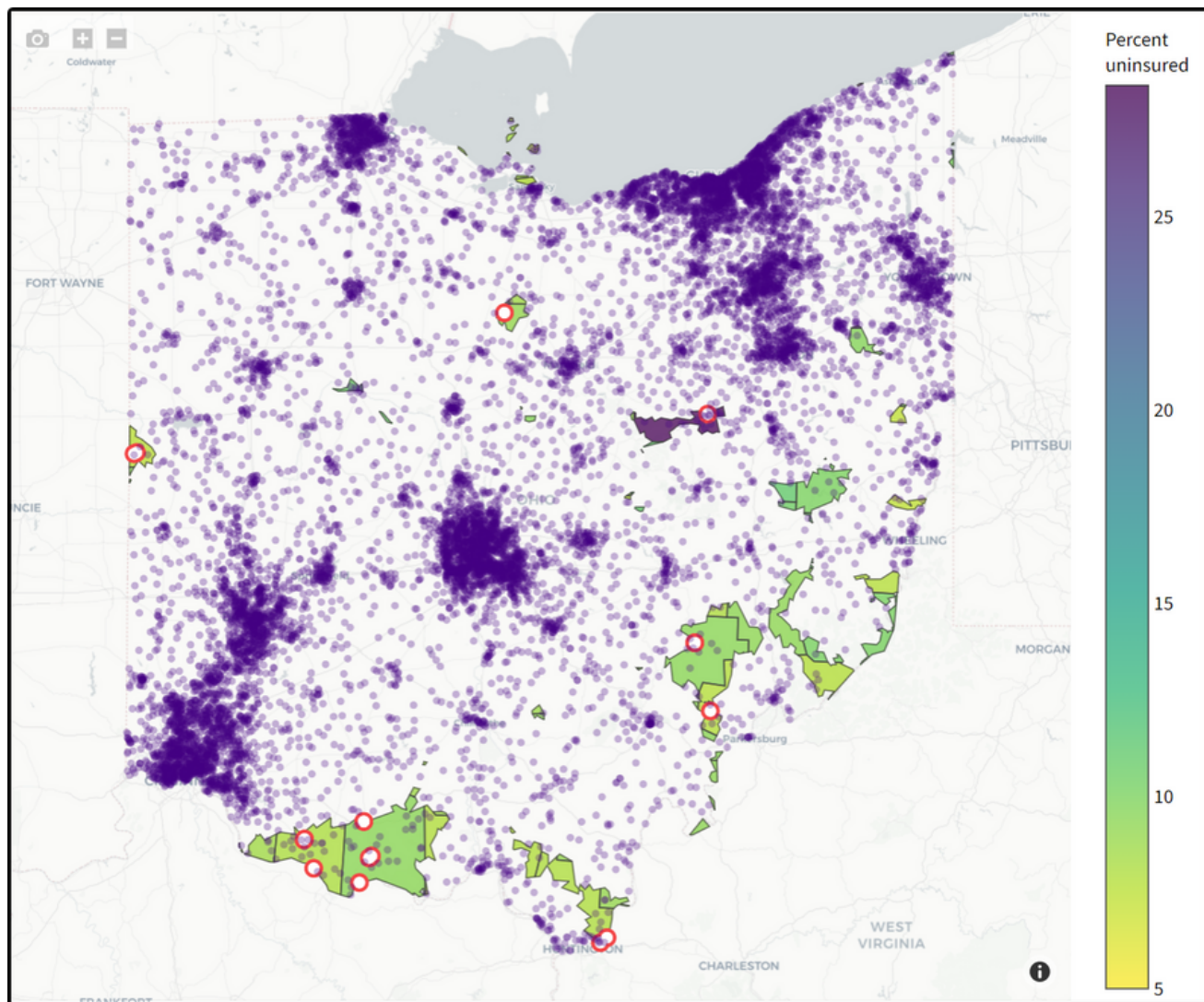
