### \*JOB OVERVIEW:

The Philadelphia Department of Public Health (PDPH), Division of Disease Control (DDC), works to prevent, control, and report on diseases and conditions that are contagious and/or affect the public's health. DDC helps prepare for public health emergencies and educate the community on how to stay safe and healthy.

The Philadelphia Department of Public Health (PDPH), through its Immunization Program in the Division of Disease Control, oversees the purchase and distribution of federally funded vaccines to local healthcare providers. As one of 64 U.S. Centers for Disease Control and Prevention (CDC) funded program areas, the Philadelphia Immunization Program is charged with the mission to prevent vaccine-preventable diseases and increase the immunization coverage levels among infants, children, adolescents, and adults in Philadelphia.

In line with this mission, the Philadelphia Immunization program runs 3 federal vaccine programs: the Vaccines for Children (VFC) Program, the Vaccines for Adults at Risk (VFAAR) program and the Bridge Access Program (BAP) Program. The Philadelphia Immunization programs works to ensure that providers can access federal vaccines, quality patient educational materials, and training for proper vaccine administration and storage and handling.

This position is Monday through Friday, 8:30 a.m. to 5:00 p.m. The position may require occasional evening or weekend hours. This is a grant-funded position; continuation of the position is continuent upon sustained funding.

### **WORK ENVIRONMENT AND PHYSICAL REQUIREMENTS**

This is not a fully remote role. Currently all staff are required to report to the office at least two times per week and this policy is subject to change. While performing the duties of this job, the employee is regularly required to stand, sit, walk, talk, and hear. This job may require moderate physical effort including lifting materials and equipment of less than 50 pounds and involves viewing a CRT or VDT screen 50 to 75 percent of the time. The position

requires responding to public health emergencies on short notice and some after-hours activities to achieve Program Objectives.

#### SUPERVISION

This position reports directly to the Immunization Deputy Program Manager.

### \*RESPONSIBILITIES:

• Serve as the section lead for the Immunization Program's Storage & Handling and Ordering & Provider Support teams.

- Develop and maintain SOPs and guides for the Storage & Handling and ordering teams.
- Create regular reports on vaccine orders, returns and wastage.
- Create regular reports on vaccine storage unit temperate data and out of range temperatures.
- Analyze ordering, return, temperature, excursion, and other related data to identify issues.
- Develop appropriate measures to address identified issues in coordination with other Immunization Program team members.
- Ensure that Storage & Handling and Ordering related grant requirements are met.
- Develop interim workflows to improve productivity and communications.
  Coordinate the addition of new vaccine products, including drafting messaging to providers, updating necessary CDC and PhilaVax databases.
- Understand the PhilaVax database and how it supports both the Ordering and Storage and Handling teams.
- Assess the functionality of PhilaVax and suggest improvements to modules as appropriate to better support the teams.
- Sit on development workgroups with IIS team and support CDC projects related to Ordering.
- Provide support to providers in ordering and storage & handling related issues.
- Complete the CDC spend plan each month.
- Work closely with other section leadership to further the Immunization Program mission.
- Participate in field response activities to support the Division's field work related to the provision of vaccines or medical countermeasures to protect exposed individuals.
- Participate in project-related conference calls, meetings, and training sessions as required.
- Participate in any exercises and real public health emergencies at the discretion of the Division Director.Other duties as assigned by Program leadership.
